

COMPETITION TERMS & CONDITIONS

1st For Women Insurance is partnering with Weelee and giving away R30 000 worth of insurance.

To enter, customers need to get an obligation free car insurance quote on the Weelee website. Competition commences on 8th August 2025 and ends on 31st August 2025.

The promotor of the competition is 1st For Women Insurance (herein after referred to as (" 1st for Women Insurance") a licensed non-life Insurer and financial services provider (FSP:5261), whose registered office is at Auto & General Park, 1 Telesure Lane, Riverglen, Dainfern, 2191.

DURATION OF THE COMPETITION

- 1 The competition commences on 8th August 2025 and ends on 31st August 2025, both days inclusive. After this date no further entries to the competition will be permitted.

WHO MAY ENTER THE COMPETITION

- 2 The competition is open to permanent residents and citizens of South Africa over the age of 18 years in possession of a valid South African Identity Document.

WHO MAY NOT ENTER THE COMPETITION

- 3 The competition is not open to-
 - 3.1 directors, members, partners, agents, employees or consultants of 1st For Women Insurance or Telesure Investment Holdings and/ or any of their associated or affiliated companies and/ or agencies or any supplier of goods or services in connection with a competition; and
 - 3.2 the spouse, life partner, business partner or associate, or the natural or adopted parent, child or sibling, of any person specified in the above.
 - 3.3 1st for Women policyholders with an active business insurance policy
- 4 You may not participate in or be eligible to win a competition if you have won a competition promoted by 1st For Women Insurance within the past three months. HOW TO ENTER

Participants will be required to get an obligation free car insurance quote to qualify to enter the competition. Winner will be randomly selected. The winner will be announced on the Weelee social media pages.

HOW MANY TIMES CAN YOU ENTER?

- 6 Only one entry will be accepted per person. Multiple entries from the same person will be disqualified.

PRIZES

- 7 Two people will stand a chance to win R30 000 worth of insurance. A representative from 1st For Women will contact the winner within 48 hours to commence with processing the win.

REQUIREMENTS YOU MUST MEET TO USE THE PRIZE

- 8 Any costs or expenses which you may incur other than in respect of those items specifically included in a prize are for your own account. 1st For Women Insurance will not be responsible for any costs or expenses which you, or your partner (if applicable), incur during and for purposes of your entry into the competition and your acceptance and/or use of a prize.

In this regard, you must collect the prize at the time and date arranged with the supplier of the prize. - 13 The winner will be notified by means of the contact details provided to 1st For Women Insurance and Weelee during the quoting process.
- 14 The Winner will be contacted by telephone and email within 48 hours of announcement. The insurance cover will start within 30 days of contacting the winner.
- 15 Winners will also be communicated on the Weelee social media pages, along with the winners' initials and surname which will be provided by 1st for Women. The winner may decline such an invitation.

WHAT HAPPENS IF THE WINNER CANNOT BE CONTACTED OR IS NOT ABLE TO TAKE UP THE PRIZE

- 16 If 1st For Women Insurance or a third party supplier is unable to contact a winner within 48 hours or if the winner does not claim the prize within 48 hours of notification, the winner will forfeit the prize and 1st For Women Insurance reserves the right to re-draw a new winner under the same conditions.

GROUND'S FOR DISQUALIFICATION

- 17 You may not win a prize if it is unlawful for 1st For Women Insurance to supply such a prize to you. If you do win such a prize, you will forfeit it.
- 18 If you fail or, if your partner (if applicable) fails, to comply with any of the terms and conditions, then without prejudice to any other remedy which 1st For Women Insurance may have, you will be automatically disqualified and you will forfeit the prize/s (in the event that you have already won a prize);
